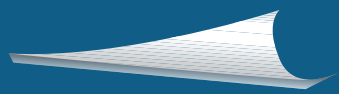

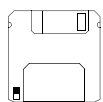

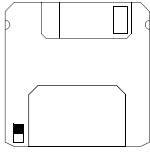

## Section 1 **User Guide to Excel® spreadsheet files**

---

### 1.1 Prerequisites

**F**irst of all, you should have a working knowledge of your computer and its operating conventions. At a minimum, you should know how to use the mouse and pull-down menus, and how to open and close files. If you need to review these techniques, please see the documentation that comes with your system, or ask your system administrator for help.

### 1.2 Requirements and system recommendations

Before you begin using *EUROCODES Spreadsheets Structural Design*, make sure that your system is set up correctly and that you have installed the required software and hardware.

You must have Microsoft® Office Professional 2003 or higher installed on your computer. No additional data disks are required. The Microsoft Excel User's Guide, particularly, covers every feature of our spreadsheets.



Our spreadsheets require at least:

- Microsoft Windows® 2000 Service Pack 3 (or greater), Windows XP;
- 128 MB of free RAM;
- 800 x 600 Super VGA Monitor, but higher resolutions are recommended;
- Pentium 233 Mhz or higher.

Obviously, you must have an internet connection.

Your installation must include the following applications, which come with Microsoft Office:

- Excel;
- Word®.



The Excel spreadsheets need the Solver (Tools) installed and do automatically the calculations providing macros have not been switched off.



If you discover that you are missing any necessary files, either use your original Microsoft Office installation disks or CD-ROM to install them, or ask your system administrator for help.



Please note that the spreadsheets will not necessarily work with previous versions of Excel (e.g. '95, 5.x etc) or other spreadsheet programs. This is due to incompatibility between software and backward incompatibility between versions.

**Note** Those not familiar with Excel are directed to the Help functions within Excel and relevant literature available at book and computer shops.

### 1.3 Activation code

First of all, you need to unlock the spreadsheets before using them. Make sure your keyword is available before launching the application.

An activation code that unlocks the individual spreadsheets you ordered will be sent to you by e-mail once your payment is received. The activation code is based on the *Name, Organisation, Postcode* you supply via internet in the field of the register application. The keyword must be entered into the form manually.

## **1.5 Before you begin**

One of the most practical habits you can develop is to make a backup copy and to save your files often. When you save a file, you ensure that it remains stored in your computer even if there is a power failure or system crash. To avoid the frustration of wasting your time, save your work regularly. Save spreadsheets to a directory and/or folder of your choice. This is particularly true where spreadsheets pertaining to a particular project are saved to a folder given the project's name. Before you begin, a backup copy on a CD-ROM is recommended to avoid using corrupted or bespoke files. If you make any mistake, start again from the base version of the spreadsheet you made on the CD-ROM. The Microsoft Excel application should be running before you start your work. When loading the individual spreadsheets, Excel may warn you about the presence of macros. It is strongly suggested that you turn the macros on ("enable macros"). All the macros provided in the files are either to launch the Solver and to allow automated printing/saving of the calculations or to provide choices by way of combo-boxes.

## **1.6 EUROCODES Spreadsheets Structural Design - Verification tests**

The spreadsheets have been developed with the goal of carry out fast calculations according to the Eurocodes (EN). The spreadsheets have been produced to cater for both first-time users and the very experienced. The spreadsheets will be issued with publications (provided electronically in the PDF format) covering their use, complete with model designs and verification tests. The data given in the "problem sketch" of each test is intended to illustrate the problem in general terms rather than to give all the data necessary to actually perform the test.



The verification tests-results given in the publications were obtained using Microsoft® Office Excel 2003 (11.5612.5606), which comes with Microsoft Office Professional Edition 2003.

- a non-transferable keyword (to unlock the spreadsheets)
- an "e-mail address" (technical support).
